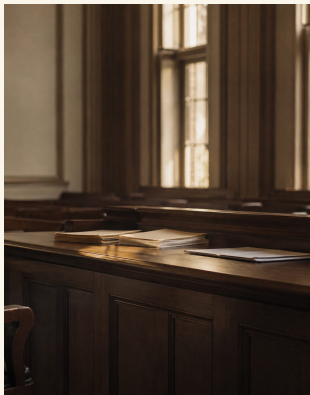

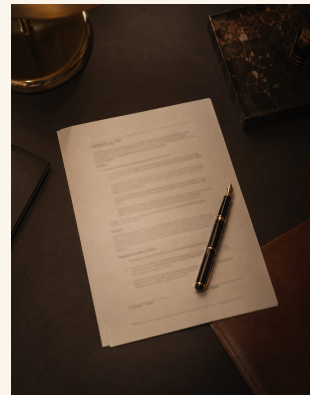

Legal Aid work has included appeals, mediations, family law property and asset division matters, applications under section 102NA of the Family Law Act, and contested trials.

Our principal has also served as duty solicitor at Mount Druitt Local Court, attending weekly to assist the court and unrepresented parties.

Our principal was engaged as in-house solicitor to the Consulate of Saudi Arabia in Sydney, holding the position for four consecutive years.

The role carried the Consulate’s full legal workload rather than a discrete brief: administrative and consular matters, commercial contracting and procurement, property and leasing arrangements, employment questions, and liaison with external counsel where specialist advice was required.

Work of this kind demands discretion, availability and an understanding of institutional decision-making. Instructions came from officers operating under diplomatic protocol and reporting lines, and advice had to be practical, prompt and defensible.

The engagement covered commercial and property work: agency agreements and contractual arrangements, property and leasing matters, and disputes arising within the franchise structure between the network, its offices and third parties.

Acting for a franchise network requires an understanding of where the franchisor's interests end and an individual office's begin, and the discipline to manage conflicts across multiple related clients within the one brand.

Our principal acted for Alan Yin, a former Raine & Horne franchisee, on charges arising from the siphoning of \$1.2 million from company trust accounts.

The prosecution case involved a substantial documentary brief and a quantum that ordinarily attracts a custodial sentence. The defence was built on the subjective case — the client's circumstances, background and prospects — and presented in detail on sentence.

The matter was reported in the Daily Telegraph.

The practice has acted in multi-million dollar asset division proceedings involving complex property structures, including matters where assets sat across companies, trusts and self-managed superannuation.

Alongside property, the practice runs contested parenting matters, including relocation, supervised time and matters where allegations require careful and sensitive handling.

Family law work is run with the same courtroom preparation as the firm's criminal practice, and settled where settlement genuinely serves the client rather than the file.
